Principals Report – Dr. Maestre presented some data analysis from testing during the 2022-2023 school year. This showed us that we still have gaps in scores between our black, white Hispanic, free and reduced lunch, ESE & ELL students in multiple subjects. We are deliberately focusing on strategies to help these sub groups of students. Boone has increased Support Facilitators from 2 last year to 5 this year. They assist ESE students in these tested subjects classrooms. The district is also allowing us to hire Tutors for Algebra 1. We are in the process of hiring 7 college students to assist!

Admin and Guidance Counselors are already looking at data for students for this year to see how it compares to last year. We want to help students understand their GPA and keeping up with their classes.

Guidance Counselors have already gone to 9th grade English classes to introduce themselves and talk about the importance of keeping up their grades. They have also started meeting 1 on 1 with seniors. Each senior will receive a graduation check indicating if they are on track to graduate or if there is something still needed.
